**▸ Linked via prior name**  
3 matches linked via prior name — sanctions publishers like UK FCDO and EU FSF don't publish IMO numbers (UK FCDO publishes zero of 6,186 active vessel/entity designations). This screen attached those matches by following the hull's documented rename history from Equasis ShipHistory. The 'linked via' chip shows the prior name; verify against the source list before acting.

**▸ OFAC 50% Rule**  
OFAC SDN names JOINT STOCK COMPANY SOVCOMFLOT as the sanctioned entity controlling this vessel. Per 31 CFR 510.214, any entity 50%+ owned by an SDN-listed party is itself blocked — treat the registered owner shown below as effectively sanctioned for transactional purposes.
